The marking shall at least be to the standards set out in the Protocol on Prohibitions or Restrictions on the Use of Mines, Booby-Traps and Other Devices, as amended on 3 May 1996, annexed to the Convention on Prohibitions or Restrictions on the Use of Certain Conventional Weapons Which May Be Deemed to Be Excessively Injurious or to Have Indiscriminate Effects".

#### 1. VICTIM ASSISTANCE

#### Article 7

Ministry of Health and Social Protection (MoHSP) aims to provide universal health coverage for all categories of population without any discrimination. Based on Law no. 10107, dated 30.03.2009 in the Health Care in the Republic of Albania", as amended, there is guaranteed health care for all. The National Health Strategy 2021-2030 "On the approval of National Strategy for Health" aims to provide health services, accessible and affordable for the whole Albanian population.

National Primary Health Care Strategy 2020-2025 aims to increase the coverage of the community with primary health care services, supporting persons with disabilities and addressing the needs and requirements for health services.

MoHSP has continued the improvement of health care facilities infrastructure through reconstruction of 340 health centers, hospitals and polyclinics. The improved infrastructure in primary health care has been accompanied with accreditation of quality standards to more than 260 health institutions, aiming toward the integration of socio-health services. The coverage and reimbursement of the drugs for categories in need, including persons with disabilities, has continued regularly.

The Trauma University hospital in Tirana provides orthopaedic prostheses. The Regional Hospital in Kukes has been transformed in a modern health service structure and standards in operation for the northern region.

Regarding social inclusion Law No. 93/2014 "On Inclusion and Accessibility of Persons with Disabilities", the modalities foresee coordination of cross-sectoral efforts for inclusion of persons with disabilities in all areas of life. Law No. 57/2019 "On Social Assistance in the Republic of Albania" foresees the benefits for persons with sisabilities, along with Law 121/2016 "On Social Care Services in the Republic of Albania". The latter provides for all municipalities to draft Social Plans, conducting needs analysis for social integrated services in the community, identifying vulnerable groups and services needed. There is

improvement in accessibility in central and local government infrastructure, where local plans for accessibility and inclusion are under implementation.

MoHSP is cooperating with partners to improve the accessibility of services near the population and continues to cooperate with UNDP on the implementation of the NAP 2021-2025, "On Persons with Disability. Moreover, Caritas Albania and Albanian Red Cross provided support for persons with disability to strengthen resilience of persons with disabilities, mental health and psycho social health and advocacy for rights of persons with disabilities.
