No legal, admnistrative and other measures were adopted within the period under consideration. The existing pieces of legislation in the main legal and judicial system of Angola (Constitution, penal code, civil code, family code and others) are sufficient to charge, prosecute and punish any national or foreign citizen who uses, produces, transfers, stores or encourages others to use antipersonnel mines within Angolan territory.

In 2022, having the need to institutionalize a single demining entity, in the scope of the state reform, in order to ensure the adoption of a single command center, as well as efficiency in the exercise of the referred activity, the National Institute of Demining and the Executive Commission of Demining were abolished, as well as the organic statute that creates the National Demining Center was approved, through the Presidential Decree 212/22, of July 23, which is subject to the superintendence of the Holder of the Executive Power, exercised by the holder of the Ministerial Department responsible for the Defense sector, under the terms of the legislation in force.

The public operator National Demining Center (CND) and the national NGO APACOMINAS have carried out land release activities in support of development projects in areas not registered in the IMSMA database, the data for which are shown in the tables below.

Because several forces participated in the Angolan conflict, many mined areas are not known to the communities and were not identified in the surveys that served as a baseline to determine the level of contamination in Angola. Taking this into consideration, and the occurrence of sporadic accidents, the government of Angola has determined that technical surveys and clearance will be carried out in areas awarded for public investment projects such as roads, hydroelectric dams, photovoltaic plants, airports, power transmission lines, industrial poles and mega agricultural projects to ensure safety in the implementation of such projects.

It is anticipated that from 2023 onwards, in the course of its operations in support of development projects, the CND will actively participate in clearing minefields registered in the database and will continue to support development projects. All areas that are identified as mined will be registered in the national database as new areas.

Explosive Ordnance Risk Education (EORE) remains a priority for Angola. The government fully recognizes the risks associated with explosive ordnance (EO) accidents, and as such, EORE activities are being carried out continuously throughout the country, but with greater emphasis on communities living near mined areas. The National Demining Center (CND) has played a key role in this process by being present in all 18 provinces of Angola. However, humanitarian operators have also made a valuable contribution in educating the populations around the areas where land clearance operations are taking place. The lack of resources for implementing EORE has significantly hindered the expansion of this activity to the more remote rural areas of the country. This causes the communities not covered to behave at risk and as a consequence, the number of accidents has increased lately. It also is important to mention that unfortunately in 2022, Angola has registerd 5 demining accidents accident.

In 2022, ith the start-up of the steering body of the National Mine Action Agency (ANAM), some activities began to be implemented with the aim of improving the performance of demining operators in Angola.

With the support of the Geneva International Centre for Humanitarian Demining (GICHD), the two deputy directors of ANAM participated in the international workshop on "All Reasonable Effort" in which a document related to the study done on the application of this concept in Angola was presented with recommendations.

The Executive Demining Commission (CED) was abolished along with all public operators working under it and the National Demining Center (CND) was created by presidential decree, which is currently the only public operator in Angola. In addition to actively participating in the clearance of areas in support of development projects, the CND also has the mission to contribute to the fulfillment of Angola's obligations under Article 5 of the Ottawa Convention.

Throughout the year three coordination meetings were held with the operators, in which the results and operational plans were discussed in order to achieve the goal of making Angola free of the impact of mines by 2025 and, if this is not possible, to substantially reduce the contamination of anti-personnel mines in the country.

In partnership with the non-governmental organization "The Halo Trust", ANAM organized in December a technical meeting in the city of Huambo with the participation of humanitarian mine clearance operators and the CND. The meeting aimed at sharing technical information about the challenges faced by operators in the field and to jointly address issues that lead to the improvement of the operators' performance.

New mined areas continued to be recorded during the year. This has somewhat hindered the completion of demining in some provinces, particularly in Cuanza Norte province where new minefields have been identified in the municipality of Lucala.

To ensure continuous improvement in the performance of the operators, ANAM in partnership with the Norwegian People's Aid (NPA), as part of the capacity development project, continued to make quality assurance and quality control visits to humanitarian operators during the course of their land release activities. NPA looks forward to continue supporting ANAM in institutional capacity development until it reaches a desired sustainable capacity.

In addition to the visits mentioned above, funded by the capacity building project, ANAM's quality assurance and quality control teams also conducted visits to the public operator.

The Angolan mine action sector has made significant strides with regard to gender balance. A considerable number of women have been actively participating in the various mine action pillars and at various levels. More than 30% of ANAM's employees are women, and some hold management positions. Currently, the

number of women employed by mine action operators has increased significantly at all levels of the hierarchy. It is noteworthy that women are employed for demining activities mainly by The Halo Trust and MAG,

Although faced with financial constraints, the government of Angola continued to financially support mine action by allocating from its budget allocations amounts to support ANAM and CND. In addition, the government continued to financially support The Halo Trust in clearing protected areas along the Okavango Delta in Cuando Cubango province.

Regarding external funding, mine action in Angola continued to receive donations from the Governments of the United States of America, United Kingdom, Norway, Belgium, Sweden, Japan and private entities. The projects implemented by international humanitarian operators, namely The Halo Trust, MAG, APN and APOPO, as well as the national NGO APACOMINAS, benefited from these donations.

Angola places great importance on transparency, and therefore this year an effort was made to ensure that the Article 7 transparency report was sent on time and with accurate data. To achieve this goal, ANAM reinforced communication with all mine action operators by involving them in the preparation of the report.
