



- Ongoing NTS as land release/cancellation methodology in line with Cambodian Mine Action Standard (CMAS) Chapter 15 Land Release

- Digitalization (paper based to online platforms)

Quality Management / Quality Control

- Annual target of 1,425 QA/QC inspections
- CMAS Chapter 19 Quality Management in Mine Action








Explosive Ordnance Risk Education (EORE)

- Number of annual casualties was reduced from 4,320 in 1996 to 44 in 2021
- Deliver EORE to 1.4 million people in affected communities annually from 2023 to 2025
